SuperRed is available in a range of sizes 6, and 10mm to suit a range of thicknesses dependent on scheme requirements. It can be supplied in AC, SMA and HRA mixes from any of our asphalt plants.

PRODUCT RANGE

SUPERRED STANDARD (RED ON BLACK)

Manufactured utilising a black binder and up to 5% by volume pigment, depending on the mix design.

SUPERRED EXTRA (RED ON RED)

Utilises a black binder and up to 5% by volume pigment depending on the mix design, incorporating a complementary red aggregate for a longer lasting colour effect; even after the surface binder has been removed.

- Allows option of visual variety for road surfaces and public areas
- Allows clients to enhance safety through colour coded demarcation areas

Surface course, thickness appropriate to the grade used and as described in BS594987.

SuperRed can be supplied as 6, and 10mm surface course..

BINDER

All grades appropriate to the BS/EN mixture selected are available, although it is recommended that the harder grades should be specified to provide maximum durability.

INSTALLATION

SuperRed is normally paver laid but can be hand laid in small areas. Where the material is to be laid on top of freshly laid and clean asphalt layers then a tack coat is not required. Care should be observed during construction to ensure that undue contamination from site derived silting and other contaminants is kept to an absolute minimum.
